The Airport Commission of the City of Mason City, Iowa will receive sealed bids at the office of the Airport Manager, Airport Terminal Building, Mason City Municipal Airport, Highway 122, Mason City, Iowa 50401 until 4:00 p.m. on May 10th, 2021. Bids received after this time will not be opened. The Commission will meet at 4:00 p.m. on May 10th, 2021 in the Airport Commission Room on the second floor of the terminal building to open and consider the submitted bids.

Description of Work

The work consists of providing equipment in accordance with Technical Specification A-800. Engineer's estimate of probable cost is \$785,000.

Contract Time Information

After issuance of Notice to Proceed, contractor may commence procurement of the specified vehicle. The Mason City Municipal Airport has established a delivery date not to exceed <u>365 Calendar Days</u> from time of Notice to Proceed. Vehicle shall be tested, delivered, and accepted within the stated timeframe. Associated training shall be complete at time of acceptance, or as coordinated with the airport.

Bid Security and Other Bonds

Bid security in the amount of five percent (5%) of the Bid must accompany each Bid in accordance with the Instructions to Bidders.

Award of Contract

All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the Airport Commission for a period not to exceed 90 days from the date of the bid opening for the purpose of conducting the bid evaluation.

It is the intent of the Airport Commission, after a period of review and evaluation, to award the contract to the responsible bidder that submits the lowest responsive proposal, meeting the requirements of the technical specifications and supplemental Owner specific additions and clarifications. The right is reserved, as the Airport Commission may require, to reject any and all bids and to waive any informality in the bids received.

Federal Provisions

This project is subject to the following Federal provisions, statutes, and regulations. Note that the full listing of federal and state provisions applicable to this project are included in Appendices A and B.

TITLE VI SOLICITATION NOTICE

The Airport Commission of the City of Mason City, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

AFFIRMATIVE ACTION REQUIREMENT

1. The Offeror's or Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth herein.

2. The goals and timetables for minority and female participation, expressed in percentage terms for the contractor's aggregate workforce in each trade on all construction work in the covered area, are as follows:

These goals are applicable to all of the contractor's construction work (whether or not it is Federal or federally-assisted) performed in the covered area. - 4. As used in this notice and in the contract resulting from this solicitation, the "covered area" is Cerro Gordo County, Iowa.

Prohibition of Segregated Facilities – 41 CFR Part 60:

- 1. The Contractor agrees that it does not and will not maintain or provide for its employees any segregated facilities at any of its establishments, and that it does not and will not permit its employees to perform their services at any location under its control where segregated facilities are maintained. - 2. <u>Disadvantaged Business Enterprise – 49 CFR Part 26:</u> The contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of this DOT-assisted contracts.
